Notably, she directed public advocacy in connection with a public policy campaign and land use and property rights lawsuit for an airfield in Cisco, Texas. Ms. Heidemanns also served as a director to the Wilks’ foundations and philanthropic efforts.

Ms. Heidemanns’ interest in public affairs stems from her past work with the Mayoral Office of The City of Fort Worth, The City of Dallas, The Massachusetts Democratic Party, and Blue Cross Blue Shield.
